



Code of Conduct Policy

Stone Tree Golf Club is committed to providing a respectful, welcoming, inclusive and safe recreational environment for our members, guests and staff. Our goal is to ensure behaviors exhibited while on the premises that respect the rights of all. It is the responsibility of everyone to abide by the Code of Conduct in order to foster a healthy culture aligned with the core values of Stone Tree Golf Club.

Membership Responsibilities

By applying for and accepting membership at Stone Tree Golf Club, every member is agreeing to the following:

1. To respect and adhere to Stone Tree Golf Course Code of Conduct and all local, provincial and federal laws.
2. To welcome new members and guests with respect, friendliness and support.
3. To act as an ambassador for Stone Tree Golf Club while at the golf club and while representing Stone Tree Golf Club club-sanctioned events.

Standards and Expectations of Player Conduct

All members and guests, whether playing golf or using other amenities, are expected to abide fully by the Code of Conduct while on premises. To meet the standards and expectations of the Code of Conduct, all members and guests shall:

1. Behave in a manner that is reflective of the personal integrity and respect governed by the Rules of Golf where it is written that we are responsible for enforcing rules upon ourselves with honesty, integrity and good sportsmanship.
2. Act in a manner free of discrimination or any form of harassing behaviour to fellow golfers, visitors or staff. This includes, but is not limited to sexual harassment, sexual assault, verbal abuse/assault, physical harassment and abuse and indecent exposure.
3. Respectfully use the golf course, amenities and facilities and repair any damage caused by play (ball marks, divot, etc.).
4. Abide by all local, provincial and national laws and regulations.
5. Comply with the dress code of Stone Tree Golf Club.
6. Respect the game of golf, by adhering to general and local rules while demonstrating the principles of golf etiquette with other players.
7. Consume alcohol and all other legal substances responsibly.
8. Refrain from bringing outside alcohol, illegal or banned substances onto the property.
9. Report incidents in a timely manner to management that are believed to be in non-compliance with the code of conduct, club policies and local, provincial and federal legislation.

Members and Guests who are found to be in violation of the Code of Conduct may be subject to disciplinary actions as determined by Management. The extent of punishment will be advised and governed by the guidelines of the Discipline Policy.



DRESS CODE POLICY

Permitted Attire:

- Men are required to wear golf shirts with collars (mock necks and turtlenecks are permitted). Shorts may be worn. Plain Tee shirts are permitted.
- Women are permitted to wear pants, slacks, shorts, skorts, capris and dresses. Mock style, v-neck and sleeveless shirts are permitted. Tops may be worn untucked.
- Hats or visors must be worn in a forward position.

Attire Not Permitted:

- No ripped jeans, jeans with holes or cut-offs.
- No tank tops, halter tops, mesh shirts or workout attire.
- Bare midriff or cleavage is not acceptable.

MEMBERSHIP TERMS AND CONDITIONS

- Members are required to check-in at the Pro Shop before every round.
- Member Golf Cart fees entitle the member to the use of a shared golf cart. Stone Tree does not allow more than 2 golf carts per foursome.
- All Members must sign a cart waiver form in the pro shop before each round of golf.
- Members are required to follow Pro Shop employees' instructions regarding starting hole, rotation of play, course maintenance, weather delays, frost delays and any other instructions provided by Stone Tree staff.
- Members are responsible for explaining the club rules to their guests and having them abide by these guidelines. All guests must check in at the Pro Shop prior to teeing off.
- Members should always pre-book a tee time before arriving at the golf course. Walk-ons will not always be accommodated.
- Tee Times may be booked starting 14 days in advance. Times can be booked online at **www.stonetree.ca**, by calling the pro shop. If you are booking tee times on line via Tee-On, please enter through the "Members" section using your personal STGA # and password. Please select and add your "playing partners" from the Stone Tree membership.
- Members are responsible for ensuring all booked tee times are filled. **The club requires 24 hours' notice of Tee Time cancellation in order to give the club a chance to resell the open tee time. Repeated failure to give 24 hours' notice will result in online privileges being revoked.**
- Management reserves the right to book four players per tee-off time. Members are NOT guaranteed to be able to play as singles, twosomes or threesomes.
- Members may not bring personal alcohol onto the golf course property, which includes the clubhouse, the pro shop, the golf course, the practice areas, driving range and parking lot. Failure to abide by this rule may result in loss of all membership privileges.
- Parents are responsible for ensuring junior members and their guests are aware of the club rules.
- Members must understand and follow proper golf etiquette.
- It is the Club's intention to ensure membership privileges are always accessible to all members; however, management reserves the right to host golf tournaments and close the course for special events.
- Junior members MUST have a G1 licence to be allowed to drive golf carts at Stone Tree. Junior members who do not have a licence are not permitted to drive golf carts.
